## **Background and Instructions**

This form is for any IETF Participant to recommend a specific (venue) city to the IETF LLC Meetings Team for consideration as a future IETF meeting venue. We ask you to provide a lot of information in this form and we recommend that you read the following before you do so that you understand why we are asking for this information:

- RFC 8719 High-Level Guidance for the Meeting Policy<sup>1</sup> of the IETF in order to understand if the city that you are recommending is eligible within the meeting rotation policy.
- RFC 8718 IETF Plenary Meeting Venue Selection Process<sup>2</sup> to understand the mandatory and important criteria that are used when we assess the suitability of a venue.

Please note the following restrictions on the use of this form in order for your recommendations to be considered:

- 1. If you represent a venue or are otherwise commercially related to the venue that you are recommending then you cannot use this form as we have a separate form<sup>3</sup> specifically for you with different questions.
- 2. This form is for recommending venues in in North America, Europe, or Asia; if you wish to recommend a venue that is not eligible within the ordinary 1-1-1 rotation policy as set out in RFC 8719 then you cannot use this form yet there is a process set out in RFC 8719 section 4<sup>4</sup> that you need to follow first.
