

Amendment #3 to RFC Production Center Agreement Term Extension

This Amendment #3 (the "Amendment") amends the RFC Production Center Agreement, dated January 1, 2016 (the "Agreement") by and between Association Management Solutions, LLC ("AMS") and Internet Society, as assigned by Internet Society to IETF Administration LLC (the "IETF") and further amended by the parties. This Amendment by and between AMS and IETF is effective as of September 24, 2019.

AMS and IETF agree as follows:

- **1. Term.** AMS and IETF agree to extend the term of the Agreement for two additional years, through December 31, 2021.
- **2. Work Standards.** AMS and IETF acknowledge and agree that, due to changes in the relevant tools and technology, the Work Standards and associated Service Levels set forth in Exhibit B of the Agreement are no longer applicable to the services to be provided by AMS under the Agreement. The parties are currently reviewing and discussing changes to Exhibit B and agree to negotiate all such changes in good faith. Until changes to Exhibit B are mutually agreed upon, AMS agrees to continue to perform the services in good faith, provided that a failure to meet the Service Levels in the course of such good faith performance will not be deemed in of itself a breach of the Agreement. The parties agree to use reasonable best efforts to mutually agree upon changes to Exhibit B in a writing signed by both parties by June 30th, 2020.
- **4. Scale Back.** For budgetary or other reasons, IETF may find it necessary to scale back on the support it receives from and the payment it makes to AMS. AMS agrees to cooperate with IETF by recommending service cutbacks and priorities to achieve the scale back target. Further, AMS agrees to cut back such services and fees as may be agreed to in writing between the parties.
- **5. Termination of Subset of Work.** IETF may terminate the Agreement as to any subset of the Work upon ninety (90) days written notice to AMS.
- **6. Notice.** The parties agree to use the address and contact information below to provide notices related to the Agreement.
- **7. Governing Law.** The Agreement and this Amendment shall be governed and interpreted in accordance with the laws of the State of Delaware without regard to its choice of law principles.
- **8. Agreement in Full Force and Effect as Amended.** Except as specifically amended hereby, all of the current terms and conditions of the Agreement shall remain in full force and effect and are hereby reaffirmed and ratified by the parties hereto in their entirety. All references to the Agreement in any other document or instrument shall be deemed to mean the Agreement, as amended prior to and by this Amendment.



9. Counterparts. This Amendment may be executed in several counterparts, each of which shall be an original. The several counterparts shall constitute a single agreement.
