

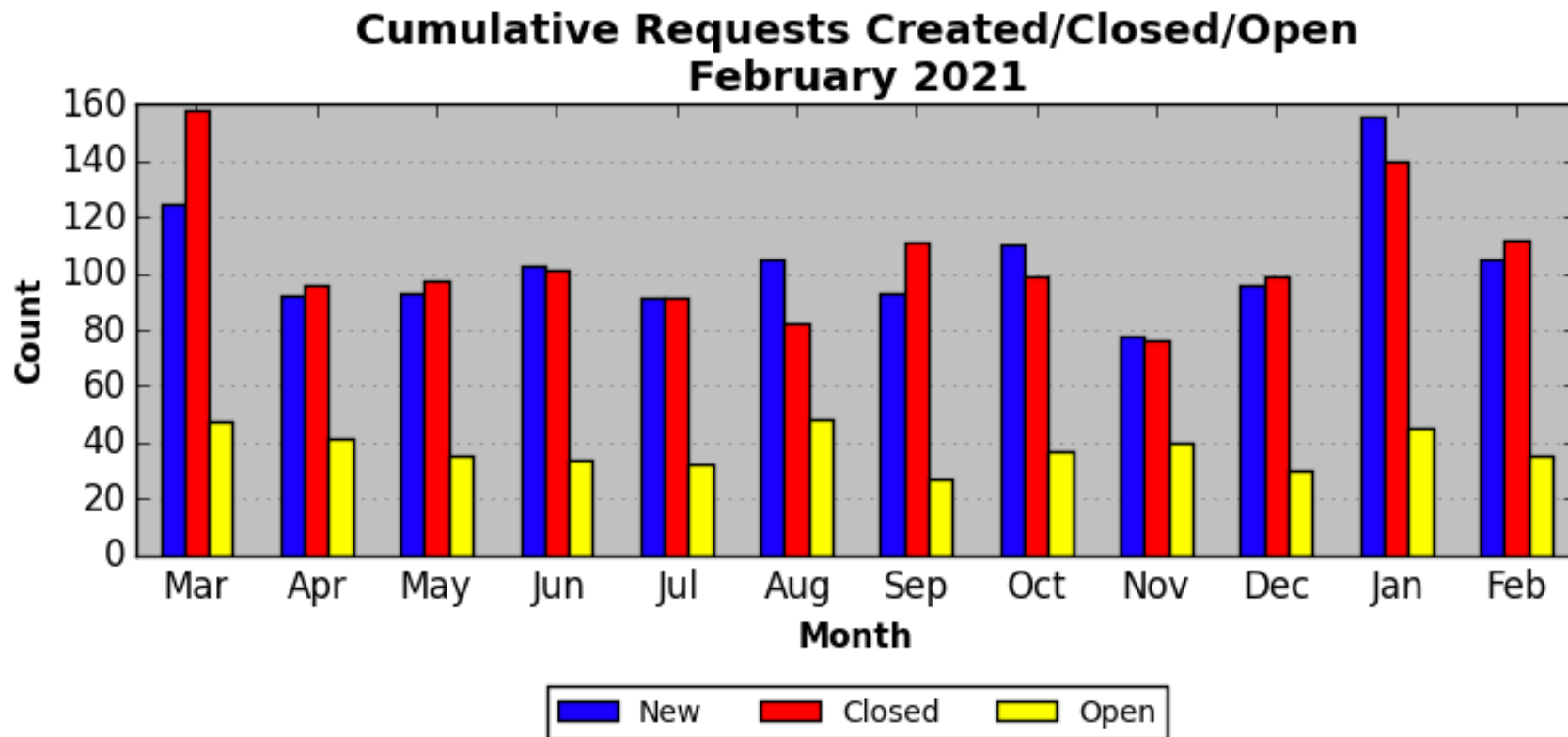

Processing IETF Related Requests

IANA Services Activity

Protocol Parameter requests since IETF-109
(November 2020 – February 2021)

Processed more than 1053 IETF-related requests.
This includes: Document reviews, registry creations, new registrations, modifications to existing registrations, and deletions.

- Reviewed 64 I-Ds in Last Call
- Reviewed 64 in IETF Evaluation
- Reviewed 71 documents becoming RFCs
(44 of the 71 documents had registry actions of some form)
- Media Type requests: 27
- Ports + Port modification requests: 30
- New Private Enterprise Numbers: 530

7 new registry URLs and 63 new registries were added since IETF-109.

Average cumulative percentage for September 2020 through February 2021 was 100%.
